With Spring nearly here and with this warm winter weather, we should be able to get an early start on clearing trails and commence our trail riding activities. Last year we had to cancel some of our early work activities due to the heavy snow, that should not be a problem this year, at least in the lower elevations. Our first trail clearing will be on the Sinlahekin trail system on March 26 & 27 followed by the Bannon Mtn. trail system on April 9 & 10. We have a huge schedule of work throughout the year so jump in now and get yourself in physical and mental shape for a busy year.

If you have reviewed our "Event Calendar" you have probably noticed that we have 17 trail rides and 12 work parties scheduled for 2010. There could be some impromptu rides and work parties announced from time to time during the summer months so watch your newsletter for any details.

We have applied for a grant to develop 2 trailheads for the newly acquired WDFW Wildlife areas, Carter Mt. off Hwy. 97, 8 miles South of Tonasket and the Horse Spring Coulee property 4 miles West of Tonasket off N. Pine Creek Rd. If the grant is approved, we should be able to start work on developing the trailheads later this summer. When finished, they will provide easily accessible early Spring and late Fall riding. Riding in those areas will be easy and will offer opportunities for conditioning horse and rider and also great for children and novice riders.

The latest on Whistler Canyon is that BLM is interested in purchasing the trailhead property from the County after the trailhead is developed. Work will start on the trailhead this fall after the apple season is over, approx. mid Sept. If we receive the BCHW grant funds for the trail improvement we will be working on that trail later this summer also. Looks like our cup is running over and if not that, surely our plate is full.

We finally found and purchased a 3 burner camp stove and BBQ grill and griddle that we can use at our various functions. We are all set for cooking almost anything now.

That's all for now, see you on the Trail.

This is to invite any BCH members to a great ride for Gentlemen. The ride is not sponsored by BCH, however in 2009 there were about 10 members of BCH on the ride.

Since 1948 men from all over the Northwest and beyond have gathered to participate in the "Gentlemen on Horseback" ride. This is a rich tradition that we can be part of. The ride was started when a group of Spokane area horsemen decided to ride their horses from Spokane to the Okanogan Valley to participate in the Washington Cattlemen's annual convention. Nowadays, we drive our rigs to a designated camping area, set up a base camp and ride out for 5 days to different attractions in the area. The rides can range from 10-25 miles a day. Riders bring their own horse, camp, and hay. The ride is catered so all meals are included in the fee of \$200. per man. Riders can also come for fewer days at \$40. per day. This is the pre-registration price for those received before June 1, 2010.

This year the ride will be staged in the Calispell basin area near Chewelah, WA. From June 20 thru 25. This is a great camp with meadow, trees for high lining and a creek. Trails go in all directions. Besides the great food, this is an outstanding dime of riding and sharing the company of other horsemen.

We also have an annual banquet on Sunday, March 21 at 6: at the Timber Creek Grill Buffet, 9211 E, Montgomery Dr. (Argonne Village) in Spokane Valley.

We talk about last year and receive more information on this year's ride as well as a slide show, entertainment and lots of laughs.
