We had a loop ride of approx. 12 miles in the Loomis Forest to the Cold Springs Look-out. On Sun. a group made a day ride up into the Pasayten Wilderness. There should be a more detailed report in the newsletter.

Last weekend there was a joint ride with the Ferry Co. Chapter. Seven riders rode up the Maple Mtn. trail and back down to the Sweat Creek Th. Three others waited at the campground and the afternoon finished with relaxing, conversation and a BBQ steak and potluck dinner.

## OCTOBER 2011 TRAIL BOSS REPORT BY TOM WINDSOR

September is history with two major rides/activities being successful and enjoyable for those who participated. The 14 Mile ride and campout was successful with members from our chapter and the Northeast Chapter all reporting a good time with no major problems. The Maple Mt. to Sweat Creek ride was enjoyed by members of both the Okanogan Valley Chapter and Ferry County Chapter. The potluck at Sweat Creek Picnic area was a hit with everyone after the ride.

The only scheduled ride for October is the Fall Color Ride in the Soap Lake area on the Colville Indian Reservation on Saturday 8 October. Contact Stan Kvistad (826-1421) for additional information on this ride.

Despite the late spring and late snow melt, we did manage to get quite a few miles of trail cleared this summer. The only trails not cleared to date are the trail from Snowshoe Cabin to Snowshoe Meadow and the Border Camp Trail from Snowshoe Meadow east to the end of the Jeep Road in the Loomis Forest.

I spent a day working with the DNR crew of Buck Sylvester and Chris Marcolin hauling cement and building forms for a new bridge on the North Fork Trail in the Loomis Forest. This bridge is scheduled for completion prior to snow fall this year. Chris Marcolin did some additional work on the Johnny Beall Trail with a mini-excavator in September. This is a multiple use trail (foot, horse and snowmobile) and is now in good shape for foot and horse traffic and a little better for snowmobile traffic.
